AVIATION QUESTION OF THE MONTH

Answer to last month's question: *You change your permanent mailing address. However, you remain in the same state, county, town, and zip code. Are you required to notify the FAA of this move? For example, you change from 104 Bordan Street, Augusta, GA 30909 to 106 Bordan Street, Augusta, GA 30909.*

According to AOPA, the Reigel Law Firm, Ltd., and the FAA: After 30 days you may not exercise the privileges of your certificate unless you notify the FAA in writing, or via the [Internet](#), of the new permanent address. Be careful with this one: It is 30 days, not one month. (Source: [FAR § 61.60](#).) According to the [Reigel Law Firm](#) “[Inconsistent addresses](#) on the documents may lead an FAA inspector to confirm the address on file with the FAA to determine which address was current and whether it matched the FAA's records. If the airman's current permanent mailing address does not match the FAA's records, the airman is technically in violation of FAR §61.60.”

This Month's Question: If a weather briefer, an FAA Flight Service Station (FSS) Specialist, tells a pilot "VFR flight not recommended." must the pilot comply with the weather briefer's recommendation? Under which weather conditions will a weather briefer tell a pilot "VFR flight not recommended"?

A VIEW OF THE EXPANDED PYRAMAX PLANT

Those flying just south of the Wrens airport can see the expanded PyraMax plant with its 300 foot stacks. It uses high heat to make tiny fracking pellets from local kaolin clay. The plant will produce 225,000 tons of pellets a year. The pellets are used to make proppant which is used in other states to help extract gas from shale. In May, 2013, PyraMax was purchased by Imerys which has five facilities in Washington County, including a calcine plant, a hydrous plant, a lands and mining operation, a technical center and a ceramics kaolin center.
